The purpose of this document is to equip you with the necessary competition specifications that will allow you to host a successful state competition.

Competition Technical Standards

The state director will provide the state technical committee with a copy of the current SkillsUSA Championships Technical Standards. The Technical Standards are the official competition guide/rules for the national SkillsUSA Championships. SkillsUSA Championships clothing requirements included in the technical standards have been established for the National Leadership and Skills Conference.

The following suggested SkillsUSA State Skill Performance Project is intended as a supplement to the guidance found in the SkillsUSA Championships Technical Standards. While most state competitive events are modeled after the national Technical Standards, rules for state events may vary from the national guidelines based on the time and/or equipment available at the state level. It is crucial that all student competitors understand any state specific requirements which should be communicated as state competition updates.

State Competition Update - Optional

Definition: A competition update is anything that is not already listed in the SkillsUSA Championships Technical Standards that a competitor and/or advisor need to be aware of and/or bring for the upcoming state competition.

State specific competition updates may include a list of materials the competitor must bring, state specific scorecard, and/or clothing allowances. Please be sure to check the “Supplied by the Technical Committee and Competitor(s)” section in the SkillsUSA Championships Technical Standards and adjust these requirements as necessary. The state technical committee, working with the state director, should establish any additional requirements needed to successfully complete the state-level competition.

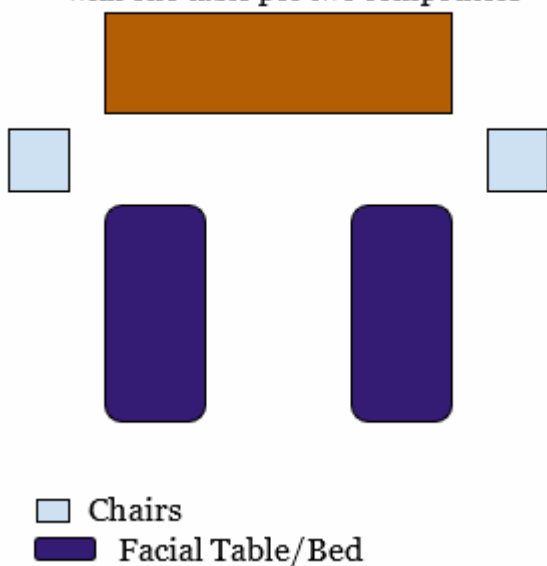

Competition Layout Details

The competitor workstations consist of the following:

- Facial bed/tables (for use in performance of facials)
- Chair (for model)
- Small table for products (*one standard 6' or 8' conference table can be set up to accommodate two competitors*)

Competition Project

Esthetics Skill Performance Stations and Time Limits:

- Competition-specific knowledge exam: 30 minutes
- Oral presentation: 2-3 minutes

Competitors will prepare and perform an oral communication presentation. This will consist of a two- to three-minute oral presentation of an analysis of skin and client consultation. Competitors will be given a skin type and should be able to recommend skin care treatment and home care regimen.

- Facial station setup: 5 minutes
- Cleansing massage: 15 minutes
- Basic facial procedure: 30 minutes
- Beauty makeup application: 60 minutes
- Fantasy makeup application: 75 minutes

Reminder: Station setups should only consist of items needed for the specific task in progress. Time will be allowed between each task to reset the table. All items should be brought to the competition site in an organized fashion.

Competition Modification Suggestion

Modification #1:

The materials needed for basic facial, and massage can be moved to items supplied by competitors to reduce consumable product costs. All towels must be basic salon size, white and without holes or stains. Competitors should be prepared to donate 2 towels at orientation for steaming. Standard salon size is approximately 15"x25" to 16"x28".

Note: All products to be in contact with the skin must be in the original manufacturer's packaging. All decontamination chemicals must be in the original manufacturer's packaging.
